Dear Chairman Beall,

The following California organizations and businesses wish to commend you for your continued pursuit for policy solutions that invest in California's transportation infrastructure and economy.

We write to you in strong support of the Short-Line Infrastructure Improvement Act of 2019 – SB 498. This innovative grant program will help short lines drive investments based on market demand, community needs and, most importantly, will help keep California farmers, agri-businesses, manufacturers, and retailers competitive in the national and global markets. The grant program will also promote efficient and cost-effective transportation for short line customers that support California workers and their families.

As you know, California's short lines handle approximately one-tenth of the state's carload freight tonnage and are a critical link between many of the state's freight-intensive industries, ports, and principal trade corridors. According to the 2018 California State Rail Plan (CSRP), inbound and outbound freight traffic are expected to increase by approximately 70 million tons by 2040 - that is on top of the near 100 million tons of total freight traffic that moves through California today.

SB 498 provides the needed catalyst to afford the short line rail industry opportunities to invest in critical infrastructure for projects that truly help rural economies, rail customers and their connections with the Class I network. These improvements not only make the short line rail system modern and efficient but also provide reductions in emissions, traffic congestion and trade corridor bottlenecks.

We support California's short line railroads, shippers, and business and urge you to pass SB 498 – the Short Line Railroad Infrastructure Act of 2019.
